People's Choice Guidelines:

- 1) Both Backyard Competitors & KCBS Teams are eligible to participate in the "People's Choice" competition in addition to the KCBS Judged competition.
- 2) Teams competing in People's choice must comply with Contra Costa County Health & Fire Departments regulations. As part of those regulations, PC Teams must have netting around their booth*, must have chafing Dishes for holding product and an approved Fire Extinguisher.
- 3) The CBCA will pay your CCC Health Department fee (\$124.00).
- 4) Competition for People's Choice is based upon public voting for Ribs, only, using designated tokens. At the end of the event, tickets & tokens will be counted to determine winner. Proceeds are split between the competitor (75%) and CBCA (25%). Money to be paid out at time of ticket counting. Teams may elect to have an overseer at the counting of tickets/tokens.
- 5) The People's Choice competitors will provide their own ribs, sauces, rubs & supplies.
- 6) Teams must cook a minimum of **24 Racks of Ribs**. Teams can **ONLY** cook & sell individual Ribs for 1 ticket each. No sales of Full Racks.
- 7) CBCA will sell tickets for \$4.00 each, at a designated location near the People's Choice destination.
- 8) People's Choice Pavilion opens to the Public at 1:00 pm and is open until all teams are out of ribs to sell.

People’s Choice FAQ’s:

Why a 75/25 split of rib sales? The CBCA is a non-profit organization. By regulations we SHOULD be splitting as 51% CBCA and 49% competitor. Because we are receiving other donations, we can offset this split to be more favorable to the competitors. All proceeds of the event are returned back to the community by supporting over 40 charities in the Clayton/Concord communities.

Chafing Dish? Last year, the Contra Costa County Health Department was very strict about this. We are recommending that you have 2 chafing dishes available. We also recommend that you use 2 Sterno’s per each dish, to assist in keeping the temps where they need to be.

Pay out? We have made arrangements to have ticket and token counters available at the end of the People’s Choice Tasting. Tokens will determine the top 3 finishers, who will be awarded medallions (as last year). Tickets will be counted, the 75/25 split applied and converted into dollars. Each ticket is worth \$4.00. Cash or “the square” payments will be immediate. Teams may have an Overseer to the counting of tickets/tokens.

Fire Extinguisher? You must have the approved fire extinguisher (2A 10 BC). This MUST be manufactured in 2018 or Recertified by August 2017. We recommend that you have your Fire Extinguisher Recertified at C.R. Fireline, Inc. (Pacheco).

Hot Box? Several of the competitors from last year have recommended that People’s Choice Teams have a Hot Box in their cook area. These can be rented from Wally’s Rentals in Concord and Pittsburg.
